

SOLID WASTE (GARBAGE) FAQ'S

CACHE WASTE CONSORTIUM (CWC) has entered into an agreement with Waste Management (WM) for Garbage Services. North Logan City is committed to providing our residents with the best service and value, we are looking forward to building a relationship with WM and anticipate a smooth transition. However, switching a major service will come with some issues, so please be patient as we work through this transitional phase over the next few months.

Residents and businesses in the following cities/towns are included in the CWC service agreement: Amalga, Clarkson, Hyde Park, Hyrum, Mendon, Millville, Newton, Nibley, North Logan, Paradise, River Heights, Trenton, Wellsville, and Unincorporated Cache County areas.

Commercial customers with dumpsters will be transitioned to WM by October 1st. Commercial customers will be asked to set up an account directly with WM and billing will be done directly by WM. Commercial customers can contact WM at 800-796-9696 with questions about their service. If you are a commercial customer and have not had contact with WM please call the North Logan City office and we can provide further information.

WM will begin service to residential customers starting October 1st. Residential Customers will continue to be billed by North Logan City each month, all questions and issues related to residential cans should be directed to North Logan City at the # above.

GARBAGE, RECYCLING & GREEN WASTE CANS

90 and 60 gallon curbside cans were acquired by Waste Management from Logan City to make the transition more fluid. Please continue to use the cans you have. If you need to make container changes please contact the North Logan City offices.

New cans acquired through WM after October 1, 2023, will be either 96 or 64 gallon capacity.

GARBAGE DAY PICKUP:

Garbage pick-up will be done on a weekly basis. The pick-up day will remain the same for North Logan residents. Cans should be out by 6:00 am on the day of pick up. Please note that pickup times throughout the day may change. For Example: In the past your cans were picked up by 8:00 am, they may now be picked up by 3:00 pm.

If for some reason your can is missed please contact the North Logan City Offices and we will work with Waste Management to ensure that your cans are emptied.

*A flier from Waste Management, with incorrect information, was sent in the last two weeks; please disregard the information pertaining to any changes in your pick up date. A new flier has been sent and should be arriving the week of September 25th.

The following hazardous household waste items should NOT be treated as everyday garbage and should NOT be disposed of curbside, in your totes, bins or carts:

- Batteries
- Electronics
- Fluorescent light bulbs
- Paint and paint cans
- Used motor oil and filters
- Prescription medications

RECYCLING:

Recycling will continue to be picked up every other week. The first pick up date for recycling by Waste Management will be the week of October 3rd or 10th depending on your assigned pick up date, and will continue every other week (please refer to your latest flier from Waste Management that you received in the mail, or contact the City Offices for more information).

Items for recycling remain the same: Plastic bottles, cans, paper and cardboard. If it's questionable, put it in your garbage can.

Do Not bag your recyclables, or place loose plastic bags in the recycling. Recyclables should be placed loosely and directly into the cans. Never put foods, liquids, foam cups/containers, plastic bags, yard waste, electronics, carpeting, clothing, furniture or tires into the recycling container. Glass is not accepted in curbside recycling. Putting these items in your recycling can could lead to the load becoming "contaminated" and fees may be assessed by WM.

GREEN WASTE:

Green Waste will be picked up each week until October 31, 2023.

Logan City green waste composting fee will no longer be charged starting in your November 2023 utility bill.

TEMPORARY DISCONNECT:

If you will not be using your full solid waste services for a minimum of two months, maximum of 6 months, you can apply through the NLC office for a temporary disconnect. During this time garbage & sewer fees will be suspended. There is a \$25.00 reinstatement fee that will be applied when services are resumed.
